Don't for get the new tax changes took effect last month: the city & School District of Pittsburgh will no longer levy the Mercantile license & tax, however it will still be collected for prior years. The City will begin to levy a .55% (.0055) on the gross payroll of all city firms and those that have activities that produce revenue within the city. Installments are due the end of February, May, August, & November. The \$10annual Occupation Tax has been replaced with the **Emergency & Municipal** Services tax of \$52 a year, deducted monthly, Employees who earn \$12,000 or less are entitled to an **Emergency & Municipal** Services refund of \$42 from the city.
