Your Chamber will be expanding the IT Clinics in 2006 to areas that are beyond the State's Tech Zones, thanks in part to the support from Citizens Bank, these 2 hour sessions will help small business owners understand the value of having automated system & use of the information super highway. The House & Senate approved HB515, lowering the personal income tax rate from the current 3.07 percent to 3.05 %. It would also change the formula for figuring the corporate net income tax, currently at 9.99%, the second highest nationally, & based only on sales made within the state. The bill would also gradually lift the \$2 million limit on the amount of net operating losses a company could carry forward and offset against its corporate net income tax liability in future years. We are one of only 3 states to have such a cap. The Governor is threatening to veto the bill, in part because of the projected \$46 million the Treasury Dept. would loose. Please call Steve Crawford in the Governor's Office to express your opposition to his proposed veto at 717-787-2531. Hurry while there is still time.
